II. **Review PLC 301.01**

Shane Goulet Presiding officer discussed with the Board what options they may have to address the concerns from Joe McCue on PLC 301.01 now PLC 901.01. Shane Goulet suggested to the Board they can send a proposal to the Executive Director to add in the phrase "or any other course which meets or exceeds the American Heart Institute standards to PLC 901.01 (H). The Board also agreed to Issue a waiver of specificity on 901.01 (H) to include the verbiage from 901.01 (F) any other course which meets or exceeds the American Heart Institute standards. to 901.01 (H). On a motion from Doreen Rossi and second by Julie Smith, the Board agreed to Issue a waiver of specificity to include verbiage from 901.01 F to 901.01 H.
