**PUBLIC MINUTES**

**JULY 6, 2022**

**I. Call to Order**

The regularly scheduled meeting of the New Hampshire Board of Medicine was held at 7 Eagle Square on July 6, 2022. Unless otherwise indicated, the members present and participating were Emily Baker, M.D., President; David Goldberg, M.D.; Jonathan Eddinger, M.D.; Jonathan Ballard, M.D.; Michael Barr, M.D.; Nina C. Gardner, Public Member; Linda M. Tatarczuch, Public Member; Susan Finerty, PAC, Richard Kardell, D.O. (attended remotely via zoom); Christine Senko, Administrator; Jessica Kennedy, Administrator; Kaylyn Marcotte, Administrator; Michael Haley, Esquire, Board Counsel. Dr. Baker, Board President, opened the meeting at 8:07 a.m.

***Motion to commence 1<sup>st</sup> non-public session:***

***8:07 a.m.*** On motion of Emily Baker, seconded by Nina Gardner, the Board voted to conduct a non-public session for the purpose of discussing investigations of alleged licensee misconduct, physician applications with irregularities and other confidential Board business and noting that such a non-public session is authorized by RSA 91-A:3, II (c), RSA 91-A:3, II (e), RSA 91-A:5, IV, RSA 329:18, I, RSA 329:18-a, IV, RSA 329:29, *Lodge v. Knowlton*, 119 N.H. 574 (1978),

*and the Board's executive and deliberative privileges. Each member recorded his or her vote on the motion, which passed by the unanimous roll call vote of all members present.*

***12:11 p.m.*** On motion of Nina Gardner, seconded by Michael Barr, the Board voted to return to public session. Each member recorded his or her vote on the motion, which passed by the unanimous roll call vote of all members present.

The Hearings Officer closed the record at 12:58 p.m. After deliberation in non-public session, the Board voted unanimously to allow Dr. Patil to establish another monitor within 60 days, upon approval after a meeting with the Board.
