## V. Medical Society Report

Jim Potter addressed the Board to review the current procedures in place for submitting continued education and went over upgrades that the Medical Society has implemented, including electronic filing. She also suggested that the Board adopt OPLC 200 practice and procedure rules. Dr. Baker requested that the BON matrix and the OPLC 200 rules be placed on the next agenda for the Board to review.
