Could you please tell me whether licensed naturopathic doctors are allowed to purchase and receive prescription medical devices (not drugs) from a wholesale distributor? N.H.Rev.Stat.Ann.§328–E:4 clearly indicates the prescription drugs and therapeutic devices that naturopathic physicians may dispense/administer, but it was not clear to me whether this would extend to prescription medical devices (asdefinedinN.H.Rev.Stat.Ann.§318:1). I would appreciate any guidance you can provide.
