**VOLUNTARY SURRENDER OF LICENSE**

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Real Estate Appraisers Board (“Board”) concerning my violations to comply with USPAP, I Peter C. Callioras, hereby voluntarily surrender my New Hampshire license (NHLR 322) effective on the date that the Board accepts this offer of voluntary surrender.


By voluntarily surrendering my license, I understand that:

1. I relinquish all rights and privileges to practice as a Real Estate Appraiser in the State of New Hampshire effective upon the Board’s acceptance of this voluntary surrender.
2. I admit that this license surrender has occurred in settlement of pending disciplinary charges.
3. I admit to no violations of USPAP SR1-1(c), SR 1-1(b), RSA 310-B:18 or RSA 310-B:18-a but recognize that the fact of my voluntary surrender will be distributed by the Board as a disciplinary action.
4. Should I again seek licensure in the State of New Hampshire, I must meet and shall bear the burden of proving compliance with all of the standards and prerequisites then required by the Board for new applicants.

5. I understand that the pending disciplinary allegations shall be resolved in any future license application I may submit in New Hampshire. I hereby specifically waive any statute of limitation or laches defense, which might then be available as to these misconduct allegations.
6. I understand that if the Board chooses to accept my surrender of license, this document shall be distributed to all relevant licensing authorities in the same manner as a final decision making specific findings of professional misconduct. I recognize that the fact of my voluntary surrender will be distributed by the Board as a disciplinary action. I further understand that this document shall become a permanent part of my file, and will be maintained by the Board as a public document.
7. I voluntarily submit this surrender of license to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
