VOLUNTARY SURRENDER OF LICENSE

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Board of Mental Health Practice ("Board"), I, Anna-Lisa Pruitt, LICSW, hereby voluntarily surrender my New Hampshire license (#761), effective on the date that I sign this *Voluntary Surrender of License*.

By retroactively voluntarily surrendering my license, I understand that:

1. I relinquish all rights and privileges to practice as a licensed social worker in the State of New Hampshire.
2. I admit that this license surrender has occurred in settlement of pending misconduct allegations that I failed to complete proper documentation when providing mental health services to a client.
3. I admit to no violations of RSA 330-A:II, and/or Mhp 500, but recognize that the fact of my *Voluntary Surrender of License* will be distributed by the Board as a disciplinary action.
4. Should I again seek licensure in the State of New Hampshire, I must meet and shall bear the burden of proving compliance with all of the standards and prerequisites then required by the Board for new applicants, including professional character requirements.

5. I understand that the pending disciplinary allegations shall be resolved via a Show Cause Hearing in any future licensure application I may submit in New Hampshire. I hereby specifically waive any statute of limitations or laches defense, which might then be available as to these misconduct allegations, including those under RSA 332-G:8 and 9.
6. I understand that this document shall be distributed to all relevant licensing authorities and professional societies in the same manner as a final decision making specific finding of professional misconduct. I further understand that this document shall become a permanent part of my file, and will be maintained by the Board as a public document.
7. I voluntarily submit this *Voluntary Surrender of License* to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
8. I understand that I have the right to seek legal counsel, at my own expense. I have entered into this *Voluntary Surrender of License* agreement after the opportunity to consult with legal counsel and with the full understanding of the legal consequences of this *Voluntary Surrender of License*.
9. I am not under the influence of any drugs or alcohol at the time I sign this *Voluntary Surrender of License*.
