**Complaint Form**

**Sworn statement of complaint for filing with the New Hampshire Real Estate Commission**

In order that the Real Estate Commission may have complete information regarding your complaint you are requested to complete this form and return it to the Commission at the above address.

RSA 331-A:28 authorizes the New Hampshire Real Estate Commission to hold hearings to determine whether the license of a real estate broker or salesperson should be revoked or suspended upon finding that the licensee has been guilty of unlawful, dishonest, deceitful, or fraudulent conduct in connection with any real estate transaction conducted by a licensed real estate broker or salesperson whether acting as a broker or principal or of any prohibited act contained in RSA 331-A and/or New Hampshire Code of Administrative Rules, Chapters Rea 100-700.

Please Type: For your complaint to be properly processed, it should be typewritten, or clearly typewritten

1. Name, address, phone number and email of person making the complaint.
2. Name and address of the broker, salesperson, accredited individual, institution or organization, or person charged with practicing unlawful brokerage activity against whom this complaint is filed.
3. Name of attorney, if any, who represents person(s) making complaint.
4. Name of attorney, if any, who represents broker(s), salesperson(s), accredited individual(s), institution or organization(s), or person(s) charged with practicing unlawful brokerage activity against whom this complaint is filed.
5. Name and address of seller and purchaser as well as the location of the property in question.
