Call To Order

The purpose of the board of veterinary medicine is to promote public health, safety, and welfare by safeguarding the people of New Hampshire against incompetent, unscrupulous, and unauthorized persons and from unprofessional or illegal practices by persons licensed to practice veterinary medicine. The right to practice veterinary medicine is a privilege granted by legislative authority to persons possessing personal and professional qualifications specified in RSA 332-B

Hearings Examiner, Attorney Nik Frye, opened non-adjudicatory hearing Docket No. 2022-VET-001; Dr. Aguilar Ramos was not present in the meeting room nor remotely via Zoom. Attorney Frye and Winifred Krogman indicated the hearing would be in recess for 15 minutes in case the respondent was late to appear.

The Hearing resumed at 8:53AM. Hearings Examiner Nik Frye noted that Juan Aguilar Ramos was not present in person or via zoom. After the Board vote noted below, the hearing was closed at 8:55AM.

Motion:

to deny the renewal application of Dr. Aguilar Ramos citing insufficient CE.

to accept Dr. Koss's application and continuing education, and approve it for license reinstatement.

Tina Kelley told that Board that if she does get OLS attorney comments, she will make any non-substantive changes and submit the FP to OLS for JLCAR approval <u>or</u> bring comments requiring substantive changes back to the Board.

Motion:

to approve the Vet 207 Final Proposal as written and to proceed with the rulemaking.

Motion moved by Stephen Crawford and motion seconded by Winifred Krogman. Passed.

2. Vet 400 - Continued Status

Tina Kelly indicated that she has only received partial comments from OLS because the rules have not been reviewed by Attorney Mike Morrell yet.

3. Vet 600 - Practice of Veterinary Medicine: Vet 601 Acupuncture, Vet 602 Embryo Transfers, Vet 603 Telemedicine

Motion:

to approve the Vet 600 Final Proposal as amended and submit the document to OLS to proceed with the rulemaking process.

Motion moved by Stephen Crawford and motion seconded by Robyn Eldredge. Passed.

4. Vet 700 - Veterinary Medical Records

Motion:

to approve the Vet 700 Final Proposal as amended and submit the document to OLS to proceed with the rulemaking process.

Motion moved by Stephen Crawford and motion seconded by Robyn Eldredge. Passed.

5. Vet 1000 - Prescription Drug Monitoring Program

Motion:

to authorize Stephen Crawford to communicate with Tina Kelley outside of the meeting for clarification and guidance on the comments and changes she suggested.

Motion moved by Winifred Krogman and motion seconded by Jill Patronagio. Passed.

D. Vet 900 - Animal Dental Care. Waiting for revised draft from OPLC Legal

Tina Kelley indicated that this Chapter of rules was not prioritized by OPLC Legal and a revised draft has not been completed.

E. Vet 300 Licensing Requirements - JLCAR postponed from 7/21/22 to 8/18/2022 meeting JLCAR draft meeting minutes 7.21.22: "Rep. McGuire moved to postpone Item #5, regarding Final Proposal 2022-38 from the Board of Veterinary medicine (Registration or Licensing Requirements), from

the July 21, 2022 agenda to the Committee's regular meeting on August 18, 2022. Rep. Bernstein seconded. Adopted"
