## July 5, 2017 MEETING PUBLIC MINUTES PAGE 1

Minutes: July 5, 2017

The regular board meeting of the New Hampshire Board of Veterinary Medicine was held at the State House Annex, Room 201, and 25 Capitol Street, Concord, NH.

Members present: President: David Stowe, DVM; Vice President: Simon George, DVM; Dr. Sonnya Dennis, DVM; John MacGregor, DVM; Elaine Forst, Temporary Public Member.

Stephen K. Crawford, DVM, Ex officio member, arrived approximately 11:15 am.

### **PUBLIC SESSION**

The public segment of the meeting was called to order at 9:18 a.m.

1. Dr. MacGregor motioned to nominate Dr. Stowe as President. Dr. Dennis seconded. So moved.
2. Dr. Dennis motioned to nominate Dr. George as Vice President. Dr. MacGregor seconded. So moved.
3. The May 4, 2017 minutes were reviewed. Dr. Crawford motioned to approve with corrections. Dr. Stowe seconded. So moved.
4. AAVSB, 2017 AAVSB Annual Meeting & Conference-reviewed, to be filed. Dr. George may attend.
5. AVMA, Coe action update-reviewed, to be filed.
6. New applicant, Marlene Hauck-go forward with licensure.
7. Rabies Certificate-discussion ensued to add practice address via rule change.
8. NH Professionals Health Program contract-reviewed and accepted/approved.

Upon the motion of Dr. MacGregor and second of Dr. Dennis the Board, by roll call vote, resolved to conduct a non-public session for the purpose of discussing investigations of alleged licensee misconduct, noting that such a non-public session is authorized by RSA 91-A:3, II (c)RSA 91-A:3, II (e), RSA 91A:5, IV, Lodge V. Knowlton, 118 NH 574 (1978), and the board's executive and deliberative privileges. Each member recorded his or her vote on the motion, which passed by unanimous vote of all members present.

The non-public segment of the meeting was held.

Upon the motion of Dr. Stowe and the second of Dr. Dennis, the Board, by roll call vote, resolved to withhold the minutes of preceding non-public sessions from public disclosure pursuant to RSA 91-A:3, III, on the grounds that public disclosure would be likely to affect adversely the reputation of a person other than a board member and to render the proposed action ineffective. Each member recorded his or her own vote on the motion, which passed by the unanimous vote of all members present.
